## Board Resolution # 1-S-2022

### Resolution Designating Signatories for Bank Accounts

**RESOLVED MOREOVER**, that any two of the foregoing officers are authorized to close any or all of the accounts of the Corporation with the Bank,

**RESOLVED FINALLY**, that all the foregoing authorities shall continue to be in full force and effect until revoked or modified by a resolution to that effect adopted by the Board of Trustees of the Organization.
