# Resolution Regarding Access to Elogbook for Residents of Suspended Programs

**WHEREAS,** the Philippine Board of Orthopaedics, Inc., is tasked with the inspection and accreditation of every orthopaedic training program in the Philippines;

**WHEREAS,** The PBO, as stated in its Manual on Policies and Procedures for Orthopaedic Residency Education, 4<sup>th</sup> Edition, revised 2019, Section F Accreditation Process, Article 4. Categories of Accreditation, Section e. Suspended Accreditation, Subsection ii, that..."The Board will allow the current residents to continue their training. However, the Board will not recognize new residents."

**WHEREAS**, A resident is considered recognized by the board if he/she was hired prior to the suspension of the program.

WHEREAS, board-recognized residents are granted access to the elogbook for proper monitoring ang logging of cases. Logged-in cases will be credited to the institution census and to the board-recognized residents' individual census.

WHEREAS, residents hired by suspended programs are not board-recognized until reinstatement of accreditation, hence said new residents are not allowed access to the elogbook.

**BE IT RESOLVED, AS IT IS HEREBY RESOLVED** that, as approved by the Trustees of The Philippine Board of Orthopaedics, Inc., access to elogbook is only allowed for board-recognized residents this 12<sup>th</sup> day of February 2020.
