Board Resolution #3-S-2023

Resolution on Voters for PBO Board of Trustees

WHEREAS, the Philippine Board of Orthopaedics, Inc. is tasked by the Philippine Orthopaedic Association, Inc. with the accreditation of all training programs and certification of all Orthopedic Surgeons in the Philippines.

WHEREAS, the Philippine Board of Orthopaedics, Inc. is a duly registered organization at the Securities and Exchange Commission (SEC) of the Republic of the Philippines, having its own constitution and by-laws, and duly elected set of officers and trustees.

WHEREAS, the **PBO**, Inc. historically held its election in conjunction with the POA, Inc. during the Annual Convention of the Philippine Orthopaedic Association, following rules and guidelines for election promulgated by the POA.

WHEREAS, only Fellows-in-good-standing and registered for the Annual Convention are allowed to cast their ballots for both the POA and PBO elections.

WHEREAS, the PBO will be conducting its own independent voting process for this coming election of officers and trustees coinciding with the 2023 POA Annual Convention using the virtual platform specifically designed for the PBO elections.

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, as approved by the Trustees of the Philippine Board of Orthopaedics, Inc., during the Board Meeting last 9th September 2023, that all Fellows-in-good-standing of the Philippine Orthopaedic Association, Inc., even if not registered and attending the Annual Convention, shall be allowed to cast their vote through the virtual platform for PBO elections.
