Board Resolution # 5 - S-2023

RESOLUTION ON THE AMENDMENT OF BR # 3-S-2023

WHEREAS, the Board of Trustees of the Philippine Board of Orthopaedics, Inc. (PBO), in its duly convened meeting, previously approved **Board Resolution No. 3- S-2023**, which provided that both registered and unregistered Fellows may be included as qualified voters in the election of new Trustees of the PBO;

WHEREAS, the Board, upon further review and deliberation, deemed it necessary to revisit and clarify the qualifications of eligible voters in order to uphold the integrity, uniformity, and credibility of the PBO electoral process;

WHEREAS, the Board recognizes the importance of aligning the voter eligibility requirements with the standards of good standing and active participation within the Philippine Orthopaedic Association, Inc. (POA), particularly during its Annual Convention where the election is conducted;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that Board Resolution No. 3-S-2023 is hereby amended, such that only registered Fellows-in-Good-Standing of the Philippine Orthopaedic Association, Inc., who are duly registered for the Annual Convention, shall be entitled to cast their votes in the election of the Trustees of the Philippine Board of Orthopaedics, Inc.;

RESOLVED, FURTHER, that this amendment shall take effect immediately upon approval and shall govern all succeeding elections of Trustees unless modified or repealed by a subsequent Board Resolution.
